8. Ordinance adopting a 2019 Budget for the City of Yakima

Assistant City Manager Cortez briefed Council on the budget ordinance. The City Clerk read the ordinance by title only.

MOTION: Gutierrez moved and Mendez seconded *to pass the ordinance*. The motion failed by a 4-3 vote, Coffey, Cousens, Hill, and White voting no.

Council Member Cousens stated in light of the financial challenges the City continues to experience, particularly inadequate reserves, the City must be disciplined.

MOTION: Cousens moved and Hill seconded to accept the 2019 budget with one exception, eliminate the Public Education Fire Captain position and transfer the salary savings to reserves. MOTION: Mendez moved and White seconded to amend the motion and remove the two positions created for the clean cities program. Assistant City o position Manager Ce erified t for the are filled positions ust be paid out of the general fund. The that can no nger be paid or with DBG f and r usen Funk Gutierrez, Hill and White voting motion to are end faile by 16-1 ve Coff till resed a point of order that it is no. After additional Council discussion, the motion carried by a 5-2 vote, Mendez and Funk voting no.

9. 2018 Affordable Housing Report

Council Member Mendez stated she thought the Council was going to have a study session on this item. Council Member Cousens stated this was her motion from several months ago to have a report; however, she prefers a study session.

MOTION: Mendez moved and Hill seconded to have an affordable housing study session sometime in January. The motion carried by a 6-1 vote, Funk voting no.

MOTION: Hill moved and Cousens seconded to eliminate this agenda item. The motion carried by a 5-2 vote, Gutierrez and Funk voting no.

10. Resolution announcing Council Business meeting schedule for 2019

City Manager Moore introduced the resolution. The City Clerk read the resolution by title only.

MOTION: Funk moved and Gutierrez seconded to adopt the resolution. The motion carried by unanimous vote.
