City Manager Harrison reported on a proposal to send a letter from the City Council to the state Commercial Aviation Coordinating Committee (CACC) to consider and study the Yakima Airport as an alternative for the three west side sites under consideration.

MOTION: Lund moved and Herrera seconded to approve letter to the state Commercial Aviation Coordinating Committee. The motion carried by unanimous vote.

MOTION: Byers moved and Lund seconded to bring the suggested documentary series concept plan on the Yakima Police Department back to the agenda at our next scheduled business meeting. The motion carried by unanimous vote.

MOTION: Cousens moved and Byers seconded to add to a future agenda to review the process of adopting proclamations. The motion carried by unanimous vote.

MOTION: Brown moved and Cousen's seconded to add to the next agenda a discussion on creating an ad hoc committee to review the domestic terrorism report by the Washington State Attorney General's office. The motion carried by unanimous vote.

Assistant Mayor Lund mentioned the January 19 Community Economic Revitatlization Board (CERB) meeting she will attend in Olympia.
