A RESOLUTION

authorizing acceptance and execution of the Washington State Transportation Improvement Board (TIB) Fuel Tax Grant Agreement for the 34th/Fruitvale/River Road Roundabouts Project 2447.

WHEREAS, the City of Yakima (City) desires to improve the functionality of the Fruitvale Boulevard and 34th Avenue Intersection by providing two roundabouts, one at the intersection of 34th Ave and Fruitvale Boulevard and one at River Road and 34th Ave; and

WHEREAS, the City was selected to receive up to 50.9049% reimbursement of eligible costs with a maximum grant of \$2,087,102 in state funding through the Fuel Tax Grant Agreement number 8-4-180(027)-1; and

WHEREAS, the City has previously received an HSIP federal grant of \$1,012,898, a NHPP federal grant of \$228,000, and a state grant of \$1,000,000 towards this project; and

WHEREAS, the match required for the TIB award will be supplied by the federal funds already awarded to the project; and

WHEREAS, the City Council finds that it is in the best interests of the City of Yakima and its residents to accept and execute the grant agreement with TIB for the 34th/Fruitvale/River Road Roundabouts project 2447, and authorize the City Manager to take all necessary steps to execute the grant agreement, necessary contracts, and administer the funds received from TIB; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF YAKIMA:

Section 1. The City Manager is hereby authorized to accept the Washington State Department Transportation Improvement Board grant, attached hereto and incorporated herein by this reference, not to exceed Two Million Eighty-Seven Thousand One Hundred and Two Dollars (\$2,087,102.00) as described in the Grant Program Agreement, and directed to take all necessary steps to secure the funding for the 34th/Fruitvale/River Road Roundabouts Project 2447.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized by the TIB award.

Section 3. The City Manager, or his designee, shall have responsibility for the administration of said funds and expenditure of said funds received pursuant to the award, which is attached hereto as Exhibit "1" and incorporated herein, and the budget submitted therewith for the TIB grant.

Section 4. The City Council hereby authorizes the City Manager to execute any and all contracts necessary and not to exceed the budgeted amounts outlined in Exhibit "1", and enter into any other necessary agreements or documents to accomplish the 34th /Fruitvale/River Road Roundabouts Project 2447 funded through the award.

Section 5. Severability. If any section, subsection, paragraph, sentence or clause of this resolution is declared invalid or unconstitutional for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of the resolution.
